#### 第52(1)條/Section 52(1)

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

From the date of sale on 4 November 2017 and thereafter, the Purchasers of any one residential unit of "Double Cove Grandview" with a saleable area of 1,453 square feet or above shall, when the Purchaser signs the Preliminary Agreement for Sale and Purchase of the said residential unit, have the right to purchase ONE of Residential Car Parking Spaces as listed in the "Price List No.1A of Parking Spaces" of Double Cove Grandview prepared by the Vendor which is available for selection at a 8% discount of the listed price(s) of the residential car parking space;

If the Purchaser fails to exercise the right to purchase the residential car parking space as stated above at the same time when the Preliminary Agreement for Sale and Purchase of the said residential unit is signed by the Purchaser, such right to purchase residential car parking space shall automatically lapse and shall not be exercisable by the Purchaser at any time thereafter.
