#### 第52(1)條/Section 52(1)

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

The Purchaser of any one of Unit as listed in this price list shall, when the Purchaser signs the Preliminary Agreement for Sale and Purchase of the said residential unit, have the right to purchase any ONE of the Residential Car Parking Space, as listed in the "Price List No.5B of Parking Spaces" prepared by the Vendor which is available for selection at a 10% discount of the listed price(s) of the residential car parking space.
