第52(1)條 / Section 52(1)

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

Purchasers can enjoy "Payment Holiday" of the second mortgage for the first 2 years , and interest on second mortgage loan will be calculated at 2% below the Hong Kong Dollar Prime Rate (P-2%p.a.) as quoted by The Hongkong and Shanghai Banking Corporation Limited (“the Hong Kong Dollar Prime Rate”) in the third and fourth years, and thereafter at the Hong Kong Dollar Prime Rate, subject to fluctuation. The second mortgage is subject to the “designated bank” offering the first mortgage loan mentioned above.
