Prior to a prospective purchaser(s) entering into a Preliminary Agreement for Sale and Purchase of a residential property, the prospective purchaser(s) (who must be individual(s)) may enter into a lease (in such form and content as specified by the Vendor) (the "Lease") with the Vendor (as landlord) in respect of such residential property.

If the tenant fails to exercise the option to purchase in accordance with its terms and conditions, the option to purchase will lapse automatically and the tenant will not be entitled to any compensation therefor.
