Purchasers will have to pay monthly instalments and interest will be accrued starting from the day of drawdown within 14 days after the date on which the Vendor issues notice to complete and interest on second mortgage loan will be calculated at 1% below the Best Lending Rate (P-1%p.a.) as quoted by The Hongkong and Shanghai Banking Corporation Limited (“the Best Lending Rate”) from time to time for the first 24 months and thereafter will be calculated at 1% above the Best Lending Rate (P+1%p.a.), subject to fluctuation. The second mortgage is subject to the “designated bank” offering the first mortgage loan mentioned above; or

(ii) the purchaser can apply to finance company arranged by the Vendor for mortgage loan, the loan amount shall not exceed 85% of the purchase price. Purchasers will have to pay monthly instalments and interest will be accrued starting from the day of drawdown within 14 days after the date on which the Vendor issues notice to complete and interest on mortgage loan will be calculated at 1% below the Best Lending Rate (P-1%p.a.) from time to time for the first 24 months and thereafter will be calculated at 1% above the Best Lending Rate (P+1%p.a.), subject to fluctuation.
