The Purchaser shall notify the Vendor in writing to apply for the "Early Completion Benefit" at least 30 days before the intended date of early completion of the sale and purchase of the Property. After the Vendor has received the application and duly verified the information to be correct, the Vendor will upon early completion apply the Early Completion Benefit amount for the part payment of the balance of the Purchase Price directly. Irrespective of whether or not the application for "Early Completion Benefit" is approved by the Vendor, the Purchaser shall complete the sale and purchase of the Property and shall pay the full Purchase Price of the Property to the Vendor in accordance with the Agreement.
