For the avoidance of doubt, the "Special Cash Rebate" Benefit shall not be applied for any purpose other than for part payment of the balance of purchase price as aforesaid.

"Licence" Benefit and "The Special Set-off Rebate" Benefit

The term of the Licence is for a period from the commencement date of the Licence to the date of completion (subject to early termination). The Purchaser shall submit written application of the Licence to the Vendor for the Licence within the period from 45 days after the signing of the Preliminary Agreement to 180 days after the signing of the Preliminary Agreement. If the application is made before 45 days or after 180 days after the signing of the Preliminary Agreement, the Vendor reserves the right in its absolute discretion to decide whether or not to grant the Licence.

- (d) 買方於接收該物業管有權之前須簽署一份經由賣方訂明的許可協議,許可協議的格式可於簽訂臨時買賣合約時於賣方代理人辦事處可供參閱。 A Licence Agreement in a prescribed form of the Vendor shall be signed by the Purchaser before taking possession of the Property. The form of the Licence Agreement is made available for inspection prior to the signing the Preliminary Agreement for Sale and Purchase at the office of the Vendor's agent.
- (e) 買方須同意負責所有法律費用(包括就許可協議而產生的印花稅(如有))。
 The Purchaser shall bear all legal costs and expenses (including stamp duty (if any)) arising from the Licence Agreement.
- (f) 在許可期內,買方不須負責物業之相關管理費、地租、差餉,但買方須負責許可期內有關物業之其他開支,在簽訂許可協議時,買方須預付公契內所要求業主繳付的管理費按金或其 他按金。

During the licence period, the Purchaser shall not be required to pay any management fees, Government rent and rates but all other outgoings of the Property during the licence period shall be borne by the Purchaser and upon signing of the Licence Agreement, the Purchaser shall pay in advance the management fee deposit and other deposit payable by an owner as required under the DMC.

"The Special Set-off Rebate" shall only be used to set off part of the balance of purchase price upon completion.

 The Licence is provided to the Purchaser only and the Purchaser shall not sub-licence the Property or any part thereof to anyone during the term of the Licence.
- (i) 其他條款細節,請向恒基物業代理有限公司職員查詢。For details of other terms and conditions, please consult the staff of Henderson Property Agency Limited.

After the Vendor has received the application and duly verified the information, and subject to the settlement of the balance of purchase price by the Purchaser, the Vendor will apply the "Early Completion Cash Rebate" Benefit for part payment of the balance of the purchase price directly. For the avoidance of doubt, the "Early Completion Cash Rebate" Benefit shall not be applied for any purpose other than for part payment of the balance of purchase price as aforesaid.

 - The Purchaser(s) (as tenant) has entered into a lease containing an option to purchase which is only exercisable by the Purchaser(s) as tenant after the 36th month of the lease term but on or before the expiration of the 39th month of the lease term (in such form and content as specified by the Vendor) (the "Lease with Option to Purchase") with the Vendor (as landlord) in respect of the residential property purchased by the purchaser(s).
- ii. 買方為該已出租之住字物業的現有租客。

The Purchaser(s) is the sitting tenant of the leased residential property.

- iii. 買方在整個含有認購權之租約期內或直至住宅物業的買賣完成日為止(以較早者為準)已妥為履行及遵守含有認購權之租約的條款及細則。
 The Purchaser(s) has duly performed and observed the terms and conditions of the Lease with Option to Purchase throughout the term of the Lease with Option to Purchase or up to the date of completion of the sale and purchase of the residential property (whichever is the earlier).
- iv. 買方(作為租客)按照含有認購權之租約的規定已向賣方(作為業主)提供一份認購通知書 (按含有認購權之租約所定義)(格式及內容由賣方訂明並附夾於含有認購權之租約)。
 The Purchaser(s) (as tenant) has duly served an Option Notice (as defined in the Lease with Option to Purchase) (in such form and content as specified by the Vendor and attached to the Lease with Option to Purchase) on the Vendor (as landlord) in accordance with the Lease with Option to Purchase.
- v. 含有認購權之租約下沒有欠繳租金。

There is no rental arrears under the Lease with Option to Purchase.

vi. 已出租之住宅物業之買賣須於已出租之住宅物業之租期屆滿時或之前完成。

Completion of the sale and purchase of the leased residential property shall take place on or before the expiration of the lease term of the leased residential property.

 Upon completion of the sale and purchase of the leased residential property, part of the Rent (as defined in the Lease with Option to Purchase), being 100% of the total sum of the Rent actually

upon completion of the sale and purchase of the leased residential property, part of the Rent (as defined in the Lease with Option to Purchase), being 100% of the total sum of the Rent actually paid by the Purchaser (as tenant) under the Lease with Option to Purchase less 2% of the Option Price (as defined in the Lease with Option to Purchase) under the Lease with Option to Purchase, will be applied towards settlement of part of the balance of purchase price directly.

All expenses in relation to the mortgage or other matters will be borne by the Purchaser. Subject to the above, each party shall bear its own solicitors' fees and disbursements.
