- (b) 每個單位A及F住宅物業：港幣\$118,000

Within 30 days after full payment of purchase price of the residential property by the Purchaser, the Vendor will give the purchaser a fixed sum cash rebate of "Christmas and New Year" benefit as listed below:

- (a) For each residential Unit C purchased : HK\$98,000 ; or
- (b) For each residential Unit A and Unit F purchased : HK\$118,000
