The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

On 15 November 2014:

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the specified residential properties (“the registrant(s)”) must follow the procedures below:-

1. Each of the registrants (or his/her authorized person) must submit the following to High One Sales Office at 3/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon (“High One Sales Office”) during the period from 6 November 2014 to 14 November 2014 (from 11:00 a.m. to 8:00 p.m.). The order of registration will not have any impact on the order of priority for selecting the residential property:
 - (a) only one Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted;
 - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2). Each cashier order shall be in the sum of HK\$100,000 and made payable to “LO & LO, SOLICITORS”; and
 - (c) a copy of the registrant’s I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate or Certificate of Incorporation and the I.D. Card of the Director of the registrant (if applicable).
2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
3. On 15 November 2014, the registrants who have submitted the registration in accordance with paragraph 1 above shall personally attend at 3/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon (“3/F, Miramar Shopping Centre”) between 10:30 a.m. and 12:00 noon (check-in timeslot for registrants). The registrants must bring along their I.D. Card(s) or (as the case may be) Passport(s) or Business Registration Certificate, Certificate of Incorporation and I.D. Card of the Director of the registrant (if applicable) and the official receipt for the Registration of Intent. The registrants whose identities have been verified by the Vendor shall be eligible for the balloting. Any registrant who arrives at 3/F, Miramar Shopping Centre at any time later than 12:00 noon on 15 November 2014 shall not be eligible for any balloting and the registration of such registrant will be deemed invalid.
4. The balloting will take place at 12:05 p.m. on 15 November 2014 and the ballot results, including “registration number” and “ballot result priority”, will be posted by the Vendor at 3/F, Miramar Shopping Centre on 15 November 2014. Registrants will not be separately notified of the ballot results. Every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent.
5. If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection without interest by the registrant (or his/her authorized person) at High One Sales Office during 16 November 2014 to 17 November 2014 (from 11:00 a.m. to 8:00 p.m.). The registrant must bring along the I.D. Card(s) or Passport(s) of the registrant (or a copy of the I.D. Card(s) or Passport(s) of the registrant if unused cashier order(s) is/are collected by the authorized person) and (if applicable) copy of Business Registration Certificate or Certificate of Incorporation of the Registrant, the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the I.D. Card or Passport of the authorized person.

After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the order of priority in the selection of the remaining specified residential properties (if any) will be on a first come first served basis.

But the Vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).

On 16 November 2014 and thereafter:

First come first served. Persons interested in purchasing must personally attend the designated place where the sale will take place.

But the Vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).

2014年11月15日:

以抽籤方式決定優先次序，有意購買該等指明住宅物業的人士或公司（下稱：登記人）須遵從下列程序：—

1. 登記人(或其獲授權人士)須於 2014 年 11 月 6 日至 2014 年 11 月 14 日期間(上午 11 時至下午 8 時)到九龍尖沙咀美麗華商場3樓曉悅售樓處（下稱：曉悅售樓處）遞交。登記次序不會影響揀選住宅物業的優先次序：
 - (a) 已填妥及由登記人簽署的購樓意向登記表格，每位登記人只可遞交 1 份購樓意向登記，重複遞交將不會受理；
 - (b) 購樓意向登記須附有本票，本票的數目須與登記人於購樓意向登記內填寫的意欲購買的住宅物業數目相同，惟該住宅物業數目不能多於 2 個。每張本票金額為港幣\$100,000 及抬頭人須為「羅文錦律師樓」；及
 - (c) 登記人的身份證或（視屬何情況而定）護照或商業登記證書或公司註冊證書和董事的身份證副本（如適用）。
2. 已繳交之本票將會作為購買指明住宅物業的部份臨時訂金。
3. 已根據上述第 1 條進行登記的登記人須於該 2014 年 11 月 15 日上午 10 時 30 分至中午 12 時（登記人報到時段）攜同其身份證或（視屬何情況而定）護照或商業登記證書、公司註冊證書和董事的身份證（如適用）及購樓意向登記表格的正式收據親臨九龍尖沙咀美麗華商場3樓（下稱：美麗華商場3樓），經賣方確認並核實身份後方可享有最終抽籤資格。於 2014 年 11 月 15 日中午 12 時任何時間後才到達美麗華商場3樓的登記人將被取消抽籤資格，其登記將被視作無效。
4. 抽籤程序將於 2014 年 11 月 15 日中午 12 時 05 分進行，賣方會將抽籤結果，包括「登記號碼」及「抽籤結果次序」於當日於美麗華商場3樓公布。登記人將不獲另行通知抽籤結果。每一份購樓意向登記表格可獲分配的籌的數目，相等於登記人於該購樓意向登記表格內填寫的意欲購買的指明住宅物業數目。當一個籌獲抽中，其相關購樓意向登記的其他籌（如有）於同一次抽籤程序將會取消及作廢。獲中籤的每份購樓意向登記的登記人只可認購不多於購樓意向登記內所填寫的意欲購買的指明住宅物業數目。
