The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

On 5 December 2014:

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the specified residential properties (“the registrant(s)”) must follow the procedures below:-

1. Each of the registrants (or his/her authorized person) must submit the following to High One Sales Office at 3/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon (“High One Sales Office”) during the period from 28 November 2014 to 3 December 2014 (from 11:00 a.m. to 8:00 p.m.) and 4 December 2014 (from 11:00 a.m. to 12:00 noon) (The order of registration will not have any impact on the order of priority for selecting the residential property):
 - (a) only one Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted;
 - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2). Each cashier order shall be in the sum of HK\$100,000 and made payable to “LO & LO, SOLICITORS”; and
 - (c) a copy of the registrant’s I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate or Certificate of Incorporation and the I.D. Card of the Director of the registrant (if applicable).
2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
3. The balloting will take place at 3:00 p.m. on 4 December 2014 and the balloting will be effected via a computer network. Every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent. The ballot results, including “registration number”, “ballot result priority” and the “check-in timeslot for registrants” will be posted by the Vendor at High One Sales Office at 6:00 p.m. on 4 December 2014. The opening hours of High One Sales Office on 4 December 2014 are from 11:00 a.m. to 8:00 p.m. Registrants will not be separately notified of the ballot results.
4. The registrants (if the registrant is a company, then any one of its directors) shall personally attend High One Sales Office, 3/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon (“designated venue”) on 5 December 2014 according to the “check-in timeslot for registrants” in the ballot results posted by the vendor. The registrants must bring along their I.D. Card(s) or (as the case may be) Passport(s) or Business Registration Certificate, Certificate of Incorporation, and I.D. Card of the Director of the registrant (if applicable) and the official receipt for the Registration of Intent. The registrants whose identities have been verified by the Agent appointed by the Vendor shall be eligible to select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot results. Registrants who arrive at the designated venue at any time later than the “check-in timeslot for registrants” assigned in the ballot results on 5 December 2014 shall not be eligible to select the specified residential properties in the order of priority according to the ballot result priorities.
5. Before entering into the Preliminary Agreement for Sale and Purchase in respect of any specified residential property, the registrant(s) may notify the Vendor on spot to add the number of purchaser(s), provided that such additional purchaser(s) must be the immediate family member(s) of the registrant(s) (only parents, spouses and children) and bring along with the relevant original valid supporting document(s) as a proof to the satisfaction of the Vendor.

6. If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection without interest by the registrant (or his/her authorized person) at High One Sales Office during 6 December 2014 to 7 December 2014 (from 11:00 a.m. to 8:00 p.m.). The registrant must bring along the I.D. Card(s) or Passport(s) of the registrant (or a copy of the I.D. Card(s) or Passport(s) of the registrant if unused cashier order(s) is/are collected by the authorized person) and (if applicable) copy of Business Registration Certificate or Certificate of Incorporation of the Registrant, the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the I.D. Card or Passport of the authorized person.

After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the order of priority in the selection of the remaining specified residential properties (if any) will be on a first come first served basis.

But the Vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).

On 6 December 2014 and thereafter:

First come first served. Persons interested in purchasing must personally attend the designated place where the sale will take place.

But the Vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).

2014 年 12 月 5 日：

以抽籤方式決定優先次序，有意購買該等指明住宅物業的人士或公司（下稱：登記人）須遵從下列程序：—

1. 登記人（或其獲授權人士）須於 2014 年 11 月 28 日至 2014 年 12 月 3 日（上午 11 時至下午 8 時）及 2014 年 12 月 4 日（上午 11 時至中午 12 時）期間到九龍尖沙咀美麗華商場 3 樓曉悅售樓處（下稱：曉悅售樓處）遞交（登記次序不會影響揀選住宅物業的優先次序）：
 - (a) 已填妥及由登記人簽署的購樓意向登記表格，每位登記人只可遞交 1 份購樓意向登記，重複遞交將不會受理；
 - (b) 購樓意向登記須附有本票，本票的數目須與登記人於購樓意向登記內填寫的意欲購買的住宅物業數目相同，惟該住宅物業數目不能多於 2 個。每張本票金額為港幣\$100,000 及抬頭人須為「羅文錦律師樓」；及
 - (c) 登記人的身份證或（視屬何情況而定）護照或商業登記證書或公司註冊證書和董事的身份證副本（如適用）。
2. 已繳交之本票將會作為購買指明住宅物業的部份臨時訂金。
3. 抽籤程序將於 2014 年 12 月 4 日下午 3 時進行，抽籤以電腦操作。每一份購樓意向登記表格可獲分配的籌的數目，相等於登記人於該購樓意向登記表格內填寫的意欲購買的指明住宅物業數目。當一個籌獲抽中，其相關購樓意向登記的其他籌（如有）於同一次抽籤程序將會取消及作廢。獲中籤的每份購樓意向登記的登記人只可認購不多於購樓意向登記內所填寫的意欲購買的指明住宅物業數目。賣方會將抽籤結果，包括「登記號碼」、「抽籤結果次序」、及「登記人報到時段」於 2014 年 12 月 4 日下午 6 時於曉悅售樓處公布。曉悅售樓處於 2014 年 12 月 4 日開放時間為上午 11 時至下午 8 時。登記人將不獲另行通知抽籤結果。
4. 登記人（如登記人為公司，則任何一位董事）須親身於 2014 年 12 月 5 日按照賣方所公布之抽籤結果中所指示的“登記人報到時段”攜同其身份證或（視屬何情況而定）護照或商業登記證書、公司註冊證書和董事的身份證（如適用）及購樓意向登記表格的正式收據親臨指定會場，經賣方委託的代理確認並核實身份後方可有資格根據抽籤結果次序揀選於當時仍可供揀選的指明住宅物業。於 2014 年 12 月 5 日，抽籤結果中所指示“登記人報到時段”後才到達指定會場的登記人將被取消根據抽籤結果揀選指明住宅物業的資格。
5. 在簽署臨時買賣合約購入任何指明住宅物業前，登記人可即場通知賣方增加買方之人數，惟加入之買家必須為登記人之直系親屬（只限父母、配偶及子女），並備妥令賣方滿意的有效證明文件正本以茲證明。

6. 如登記人並無購入任何指明住宅物業或其購入之指明住宅物業數目未達其於購樓意向登記內所填寫意欲購買之數目，登記人（或其獲授權人士）可於 2014 年 12 月 6 日至 12 月 7 日上午 11 時至下午 8 時內於曉悅售樓處辦理無息取回未使用的本票。登記人須攜同登記人身份證或護照正本（如以獲授權人士取回未使用的本票，則須攜同登記人身份證或護照副本）及（如適用）登記人之商業登記證書或公司註冊證書副本、有效的購樓意向登記收據正本、及（如適用）有效的授權書及獲授權人士之身份證或護照副本。

當抽籤及合資格人士選購指明住宅物業完畢後，餘下的指定住宅物業（如有）將以先到先得形式發售。
