The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

On 24 April 2014:

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the specified residential properties (“the registrant(s)”) must follow the procedures below:-

1. The registrants (if the registrant is a company, then any one of its directors) shall personally attend 5/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon (“designated venue”) from 7:00 p.m. to 8:00 p.m. (“check-in time slot”) on 24 April 2015. Each of the registrant(s) must:
 - (a) Complete and signed only one Registration of Intent on the spot. Duplicated submission will not be accepted;
 - (b) Bring along cashier order(s), the number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed one (1). Each cashier order shall be in the sum of HK\$100,000 and made payable to “LO & LO, SOLICITORS”; and
 - (c) Bring along a copy of the registrant’s ID Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate or Certificate of Incorporation and the ID Card of the Director of the registrant (if applicable). The order of registration will not have any impact on the order of priority for selecting the residential property.
2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
3. The balloting will take place at 8:05 p.m. on 24 April 2015. Every valid Registration of Intent shall be allotted one lot. Once a lot allotted to a Registration of Intent has been successfully drawn, the registrant shall be eligible to select not more than one (1) of the specified residential properties which are still available at the time of selection in the order of priority according to the ballot results.
4. Registrant(s) who arrive at the designated venue at any time later than the “check-in time slot” on 24 April 2015 shall not be eligible to select the specified residential properties in the order of priority according to the ballot results.

After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the order of priority in the selection of the remaining specified residential properties (if any) will be on a first come first served basis.

But the vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).

On 25 April 2015 and thereafter:

First come first served. Persons interested in purchasing must personally attend the designated place where the sale will take place. Vendor does not accept any person interested in purchasing having queued up before the time of sale (according to the place where the sale is to take place).

But the vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).

2015年4月24日:

以抽籤方式決定優先次序，有意購買該等指明住宅物業的人士或公司（下稱：登記人）須遵從下列程序:-

1. 登記人（如登記人為公司，則任何一位董事）須親身於 2015 年 4 月 24 日（出售當日）下午 7 時至下午 8 時（下稱：報到時段）到九龍尖沙咀美麗華商場 5 樓（下稱：指定會場）報到，並需要：
 - (a) 即場填妥及簽署購樓意向登記表格，每個登記人只可遞交 1 份購樓意向登記，重複遞交將不會受理；
 - (b) 攜同銀行本票，本票的數目須與登記人於購樓意向登記內填寫的意欲購買的住宅物業數目相同，惟該住宅物業數目不能多於 1 個。每張本票金額為港幣\$100,000 及抬頭人須為「羅文錦律師樓」；及
 - (c) 攜同身份證或（視屬何情況而定）護照或商業登記證書或公司註冊證書和董事的身份證副本（如適用）。登記次序不會影響揀選住宅物業的優先次序。
2. 已繳交之本票將會作為購買指明住宅物業的部份臨時訂金。
3. 抽籤程序將於 2015 年 4 月 24 日下午 8 時 05 分進行。每一份購樓意向登記表格可獲分配一個籌，當一個籌獲抽中，登記人方可有資格根據抽籤結果順序揀選於當時仍可供揀選的指明住宅物業不多於 1 個。
4. 於 2015 年 4 月 24 日，報到時段後才到達指定會場的登記人將被取消抽籤揀選指明住宅物業的資格。

當抽籤及合資格人士選購指明住宅物業完畢後，餘下的指定住宅物業（如有）將以先到先得形式發售。

2015年4月25日起:
