On 5 September 2014:

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the specified residential properties ("the registrant(s)") must follow the procedures below:-

- 1. Each of the registrants (or his/her authorized person) must submit the following to High One Grand Sales Office at 3/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon ("High One Grand Sales Office") during the period after the issue of price list to 4 September 2014 (from 11:00 a.m. to 8:00 p.m.). The order of registration will not have any impact on the order of priority for selecting the residential property:
 - (a) only one Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted;
 - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2).
