First come first served. Persons interested in purchasing must personally attend the designated place where the sale will take place.

On 22 March 2015: Vendor does not accept any person interested in purchasing having queued up before 11:00 a.m.

From 23 March 2015 and thereafter: Vendor does not accept any person interested in purchasing having queued up before the time of sale (according to the place where the sale is to take place).

But the vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).
