Eligible tenderer(s) for “Tender Period No. 1” must be (i) person(s) / company(ies) who has/have entered into a Preliminary Agreement for Sale and Purchase with the Vendor in respect of a residential unit being either Flat A or Flat B of Tower 1 of the Development, (ii) person(s) / company(ies) who has/have purchased from the Vendor directly and is/ are currently the registered owner(s) of a residential unit being either Flat A or Flat B of Tower 1 of the Development or (iii) person(s) whose parent(s), child(ren) or spouse(s) (collectively, “Close Relative(s)”) belong(s) to the category of person(s) described in (i) and (ii) above (collectively, “Eligible Tenderer(s)”). (If applicable) Eligible Tenderer(s) is/are be required to produce relevant documentary evidence for proof of relationship between the Eligible Tenderer(s) and the Close Relative(s). 3. The tender notice and other relevant tender documents will be made available for collection free of charge at the Sales Office during opening hours (i.e. from 11:30 a.m. to 8:00 p.m.) from no later than 11:30 a.m. on 30 January 2026 to 8:00 p.m. on 29 July 2026.

4. The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/or time of the tender and/or the place where the sale will take place in respect of all or any of the specified residential properties from time to time by amending and/or issuing the Information on Sales Arrangements.

For safety and maintenance of order at the Sales Office, the Vendor reserves its absolute right to, in the case where the Vendor considers that there being any event or circumstance affecting or which may affect the safety, order or public health in the Sales Office and/or its vicinity, postpone, extend or modify the date, time, period, place of sale or selection of specified residential properties or other procedures to such other date, time, period or place as the Vendor may consider appropriate. Details will be announced on the website of the Development and persons interested in purchasing the specified residential properties will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.
